

RATES FOR WATER SUPPLIED TO FLAT RATE
RESIDENTIAL CONSUMERS
(Single Family Units)

AVAILABILITY

These fixture rates are closed to all new customers. Existing customers may be permitted to continue on flat rate at the option of the Town Council until such time as meters may be installed. Seasonal or summer customers will be billed the amount used and or time used. Any dwelling to accommodate more than one family will be included under Tariff Page 2 (metered).

RATES

BIMONTHLY

20.25% MORE THAN METERED MINIMUM RATE

\$ 36.45

MINIMUM CHARGE

No service will be furnished for less than twenty and one quarter percent (20.25%) of the minimum rate.

CONDITION OF CONTRACT

The amount payable shall be an amount determined by the minimum metered rate at the time of billing.

TERMS OF PAYMENT

Bills on the flat rate basis shall be payable bimonthly.

RATES FOR WATER SUPPLIED TO METERED CUSTOMERS

AVAILABILITY

To all metered customers for Commerical, Industrial and Governmental use. Includes any dwelling to accommodate more than one family or modified to provide one or more apartments, tenants, or units for rental purposes.

RATES

First 800 cubic feet per bimonthly or fraction thereof	\$ 30.31
Next 3,200 cubic feet per bimonthly	\$ 2.26 per 100 cu.ft.
Next 8,000 cubic feet per bimonthly	\$ 1.49 per 100 cu.ft.
Next 12,000 cubic feet per bimonthly	\$ 1.25 per 100 cu.ft.
Next 24,000 cubic feet per bimonthly	\$.75 per 100 cu.ft.
Next 48,000 cubic feet per bimonthly	\$.61 per 100 cu.ft.
Over 96,000 cubic feet per bimonthly	\$.36 per 100 cu.ft.

CONDITIONS OF CONTRACT

RATES FOR PRIVATE FIRE PROTECTION

AVAILABILITY

To all consumers using the District's facilities for private fire service, having separate lines for this service.

The following rate applies to fire service only and includes no allowance of water for other than fire fighting purposes.

RATES

	<u>Annual</u>
For each 4" service line	\$362.50
For each 6" service line	\$543.75
For each 8" service line	\$725.00
For each 10" service line	\$906.25

There will be no charge in addition to this for sprinkler heads, or hydrants supplied from the service line when installed and maintained by the consumer.

CONDITIONS OF CONTRACT

The District reserves the right to meter any fire line when evidence indicates that water is being taken from the line for purposes other than fire protection, and such metered service shall be billed in accordance with the regular schedule of meter rates, in addition to the above rates, with proper allowance for water consumed in fire fighting.

TERMS OF PAYMENT

All Private Fire Protection charges payable in advance on a bimonthly basis.

PUBLIC FIRE PROTECTION

AVAILABILITY

To the Town of Fort Kent for Municipal Fire Protection

RATE

For the existing 92 as installed on existing mains
on December 31, 2001, a total charge per year of :

\$100,000.00

Rates for hydrants installed after December 31, 2001
shall be determined in accordance with the Public Utilities
Commission Rules and Regulations Chapter 690.

CONDITIONS OF CONTRACT

The hydrant charge shall not be reduced should the town order one or more hydrants
discontinued.

TERMS OF PAYMENT

All Public Fire Protection charges payable bimonthly in advance.

INTEREST ON UNPAID BILLS

CHARGE

A charge of .833% will be assessed after 30 days from the billing date on all unpaid water
bills.
