Motion was made by Andrew Caron and seconded by Jake Robichaud to approve the wastewater abatement in the amount of \$45.36. All in favor, motion carried.


Motion was made by Andrew Caron and seconded by Carroll Theriault to exit executive session at 5:25pm. All in favor, motion carried.



No action taken as we have not received the final draft of the contracts.




**17. OTHER**
