11. REVOLVING LOAN FUND – STATUS [1 MRSA § 405 (6) (C)]


Motion was made by Andrew Caron and seconded by Joey Ouellette to enter executive session at 4:55 pm. All in favor, motion carried.


Motion was made by Corey Pelletier and seconded by Joey Ouellette to exit executive session at 5:15 pm. All in favor, motion carried.


12. OTHER

Motion was made by Andrew Caron and seconded by Joey Ouellette to adjourn at 5:20pm. All in favor, motion carried.


